**Approval of Minutes**

The monthly bills and financial report for the month were reviewed. There was a discussion with a financial review. We are awaiting payment from UCE and CFDN, which is delayed due to the pending PO number. Still \$50,000 in debt.

**ONGOING DISTRICT BUSINESS**

District Manager R. Sahota gave an update on the CAPGP, only one monarch habitat was done. We have gotten great feedback from Glenn and Sonoma County that we can contract our employees. Will be walked through the process by Kandi so it can be done for our RCD.

District Manager R. Sahota updated that activity in HSP/SWEEP program; they're not looking to do a block grant. It's probably going to be the individual or CDs that apply. There is money available in this grant and being up to date with us getting paid.

District Manager R. Sahota gave an update on the CFDN, attended a workshop that taught and trained how to do soil sampling. Since we will start to work on soil sampling beginning next month.

District Manager R. Sahota gave an update on the Cal-Recycle program, received an email back for our last cycle that we applied for, they did not accept the application due to only having two pictures. Will now have to resubmit Jan/Dec the application and they are now needing three pictures for each site.

District Manager R. Sahota gave an update on the WCB Monarch Habitat. We are looking to create another site for the monarch habitat. We've been talking to Cheryl from the master gardeners to see if we can get to the Fair Grounds and plant around the community garden. Was also approached by a Bouge temple member and they are also interested in planting there also- they will not need irrigation and maintenance since they already had that. Will be replacing the missing/dead plants from the Live Oak trail location since the rainy season has begun.

Director M. Johnston gave an update on the Feather River WCB grant that has been funded, all contracts should be done within the next 20-30 days. Work will be starting the first of January.
