District Manager R. Sahota gave an update on the **CFDN**, evaluation done on September 20, for the first year went great. Next evaluation will be June 2025.

District Manager R. Sahota gave an update of **CUSP Drought Grant**, Invoices are all paid to date. Outreach is still happening for this project but is not accepting fund applications from growers.

District Manager R. Sahota gave an update on the **Cal-Recycle program**, phase for April 1st was approved. Next phase has been applied for two weeks in advance for eight sites.

District Manager R. Sahota gave no update on the **Equity grant**, nothing new - grant is ending in April 2025. Will be doing outreach two days in the month of October (18 & 30) at the Sikh Temple parade. Saved one day for it to roll over for the 2025 parade.

District Manager R. Sahota gave an update on the **Monarch Habitat** - Received seeds in September. They are being stored in a refrigerator until the rainy season starts. They will all be planted for the ones that went missing due to the excessive heat.
